Preventive measures to minimize the spread of the COVID-19 disease in conditions of company JAVYS, a.s

1. INTRODUCTION

In connection with current situation regarding the spread of the COVID-19 disease, the *Crisis Committee* meeting was called in Jadrová a vyraďovacia spoločnosť, a.s. (hereinafter referred to as "JAVYS, a.s."), where further measures were adopted. These measures constitute a set of instructions, regulations, recommendations, guidelines and information that any person entering the premises of company JAVYS, a.s. is obliged to become familiar with and observe. The entering person is considered to be each person entering the premises of company JAVYS, a.s.

The *Preventive Measures* are complementary measures and recommendations to valid and effective internal management documentation of company JAVYS, a.s., which all persons entering the premises of company JAVYS, a.s. shall become familiar with.

Depending on the situation, all necessary information is continuously updated on the Intranet and website of company JAVYS, a.s. Information related to the COVID-19 disease is also available on the website of *Public Health Authority of the Slovak Republic* (hereinafter referred to as "PHA SR") and other publicly available information sources.

There are no registered persons with the COVID-19 disease in company JAVYS, a.s.

2. RECOMMENDATION

Company JAVYS, a.s. recommends all employees of company of JAVYS, a.s., with special emphasis on employees working in the controlled area, to avoid any places, premises, events, situations, etc. with presence of a larger number of persons, in order to protect the health of their

own and others. At the same time, we request all employees of company JAVYS, a.s. to respect measures adopted against the spread of COVID-19 disease and to consistently use the hand disinfection and observe the personal hygiene in all areas/premises of company JAVYS a.s. We firmly believe that, by working together and coordinating procedures, we can minimize the possibility of contagion in JAVYS, a.s., while having to pay special attention, in the upcoming period, particularly to places where more people are expected to be present, especially in the entrance areas to company JAVYS, a.s., in sanitary premises as well as in specific workplaces, where works are being implemented. In connection herewith, the *Crisis Committee* of company JAVYS, a.s. adopted a number of measures aimed at ensuring, maximal possible protection of health of persons entering and located in premises of JAVYS, a.s.

3. PREVENTIVE MEASURES

Preventive measures in company JAVYS, a.s. are reflected in Amendment No. 2 to the Order issued by the CEO under ref. JAVYS/PGR - 09/2020 and in the Minutes of the CEO meeting held in company JAVYS, a.s. on the 25th of August 2020. The aim of measures adopted by company JAVYS, a.s. to prevent the transmission and spread of the COVID-19 disease is to minimize the risk of spread of the COVID-19 disease. The Order issued by the CEO, including its Amendments, is binding for all employees of company JAVYS, a.s., as well as for all persons entering the premises of company JAVYS, a.s., and this Order issued by the CEO was also sent to all contractual partners of company JAVYS, a.s. for them to be become familiar with. The most important measures include:

Body temperature measurement

Every time, when entering the premises of company JAVYS, a.s., each person entering shall be obliged to undergo the body temperature measurement process, after which it is decided whether such person is to be allowed to enter or is to be refused an entry. The refusal to undergo the body temperature measurement will automatically be considered as a reason based on which an entering person will be refused to enter the premises of company JAVYS, a.s.

This obligation also applies to persons entering the building 636:V1 "V1 NPP Decommissioning Centre" and to persons entering the building 632a "JESS, a.s. - Administrative Building" and building of the "Medical Centre".

We recommend that the persons entering have their body temperature measured individually as a precautionary measure before they enter the premises of company JAVYS, a.s. and if, in this inspection place, their body temperature exceeds 37.5 degrees, they report this by e-mail to the relevant superior and to the following e-mail address: vstupy@javys.sk. After reporting health-related problems or elevated body temperature beforehand, their ID card will be temporarily blocked due to preventive measures of JAVYS, a.s. This ID card will be unblocked after their health issues have subsided or after the next measurement of body temperature with negative results.

Respiratory/airways protection obligation

All persons entering the premises of company JAVYS, a.s. are requested to use, in buildings' interiors, respiratory protection equipment, such as masks, respirators or other suitable protective equipment, such as scarves, bandanas, etc. In the event that the person entering has no respiratory protection or refuses to use respiratory protection, he/she will not be allowed to enter company JAVYS, a.s.

Disinfection

Personal disinfectants intended for hand disinfection are provided and prepared at the entrance gates and in all locations identified as risky due to the large concentration of persons.

At the same time, we would like to point out that thorough hand washing is the first and most important thing we can do to combat the new coronavirus. In the context of the above, always wash your hands thoroughly after every return from the outside areas, or if you feel that your hands are dirty, after travelling in a vehicle/means of transport, before eating, after each use of the toilet, after handling the waste and waste bin, etc.

Disinfection of workplaces and premises

Company JAVYS, a.s. is to ensure more frequent disinfection of workplaces and premises, which may be potentially contaminated, especially premises with large concentration of persons and items, where there is an increased risk of the spread of the disease (door handles, toilets, switches, service equipment, etc.).

Works organization

Any visits to premises of company JAVYS, a.s. are prohibited. The exemption may be granted by the CEO of JAVYS, a.s. Premises of company JAVYS, a.s. may be entered only for the purposes of implementation of works, delivery of services and goods, while staying in the premises of JAVYS, a.s. is limited to necessary time.

4. GENERAL MEASURES

Organizing the meetings and work meetings / workshops

It is prohibited to organize meetings and work meetings/workshops with more than 10 participants in premises of company JAVYS, a.s. You are kindly requested to coordinate your activities so that no more than 10 persons are gathered in one place or in one room.

During communication, it is necessary to preferentially use telephone and e-mail form of communication, if the nature of the works or provided services allows to do so. If this is not possible it is required to communicate, while using the face masks (have a mouth covered) and keeping a safe distance.

Other measures

During breaks, especially smoking breaks, it is necessary to observe the above-mentioned rules - a distance between persons and also prohibition of gathering of more than 10 persons in one place or specific areas for a break.

5. CONCLUSION

Each of us can contribute to reducing the risk of infection, especially by personal responsibility and complying with the rules. Only then an active and timely approach of the company can produce good results.

We would like to thank all our employees and contractual partners for their constructive approach to dealing with the spread of the coronavirus. We are doing our best to protect the health of all employees and Contractors of company JAVYS a.s. We are adopting measures that are appropriate to current situation regarding the spread of the COVID-19 disease.

A high level of personal responsibility of each individual, a coordinated and systematic approach of all of us, as well as discipline required to comply with the rules, are essential to manage this situation. We believe that we will demonstrate this proper and responsible approach and ensure effective compliance with the rules.

We are aware of the fact that today there are no measures to completely eliminate the risk of the disease transmission, but we need to do our best to protect the health of our employees as well as employees of our contractual partners.

Company JAVYS, a.s. continues to monitor the development of epidemiological situation and is ready to adopt further measures in case of unfavourable development of the situation.
