

INVITATION TO PARTICIPATE IN PUBLIC TENDER REGARDING SELLING OF ASSET USED CONTROL SYSTEM PARTS VI

Dear business partner,

Nuclear and Decommissioning Company, plc., (hereinafter referred to only as "Seller") is organizing a public tender for the purpose of assets selling – used control system parts VI from nuclear power plant V1. The assets in question are sold as a whole.

1. SPECIFICATION OF ASSETS

a) Assets sold - used control system parts VI, which were used in operation of NPP V1:

Modul SLLM (6FK5243-8AA) 30 pc

b) If interested, it is possible to organize visual inspection of assets to be sold on the site in Jaslovské Bohunice. The date of this inspection is set on 11.04.2025 at 9:30 a.m. Only two employees of potential Tenderer may participate on this inspection. At least two working days before the date of inspection it is necessary to send the identification data of participants (name and surname, date of birth, identity card number) to the address: koptak.juraj@javys.sk, jurik.daniel@javys.sk due to the arrangement of entrance permissions to JAVYS, a.s. Subsequently, you will be sent a form with instructions on the conditions of entry into the company JAVYS, a.s..

2. CONDITIONS OF SALE

a) The bid submitting:

According to the conditions set out in point 3 of this invitation "Delivery and content of the bid" and according to Annex No. 1 of this invitation "The Bid"...

- b) **Validity of the bid** Minimum until 17.07.2025.
- c) Evaluation criterion / Subject of the evaluation: Total price for the assets being sold in EUR excluding VAT (Price for 30 pcs)
- d) The Seller reserves the right:
 - in the event of a sufficient number of submitted price offers, to hold an electronic auction in which bidders whose price offers meet the prescribed requirements will be able to participate,
 - to ask bidders to increase the submitted price offer,
 - not to accept any of the submitted price offers without giving a reason,
 - to cancel the public bidding procedure without giving a reason.



e) **Results of the public bidding procedure:**

The results of the public bidding procedure will be announced to the bidders after the evaluation of the offers and the signing of the minutes of the meeting of the evaluation committee for the evaluation of the offers for the sale of control systems VI.

f) **Purchase contract:**

The winner of the bidding procedure will be contacted and a draft purchase contract will be sent to him. After it is signed and delivered to the seller, it will be signed by the seller and an advance invoice will be issued. The agreed price must be paid in a lump sum in advance to the seller's account within 14 calendar days from the date of delivery of the advance invoice by the seller to the buyer, as stated in the draft purchase contract

g) Handling, loading and removal of assets from the seller's premises in Jaslovské Bohunice:

The seller, based on an agreement with the buyer, will appropriately pack the object of sale and prepare it for collection by the buyer. The object of sale will be collected by the buyer or a person designated by him. The buyer will pay the full cost of any transport to the destination. In the event of using the services of a transport company, the buyer will notify the seller of relevant information about the transport (transport company, contact details, time of delivery of the shipment, etc.) in good time. The object of sale (shipment) must be collected by the transport company at the registered office of JAVYS, a.s in Jaslovské Bohunice. The seller will hand over the item of sale to the shipping company based on the shipping details from the buyer.
